### Problem

Thomas Randolph, the Director of Information Technology for St. Louis Public Schools, listed the following reasons to implement an email archiving solution:

- Compliance with current legal guidelines on maintaining electronic records. These include the new Federal Rules of Civil Procedure.
- Secure storage of and access to the increasing volume of incoming, outgoing and internal email generated by the district's 5000-plus employees. Current volume is approximately 500,000 messages per month.
- The time-consuming, labor-intensive process of recovering email that staff members delete from their individual mailboxes. (See sidebar, page 2.)
- With a limited IT budget and a staff of eight technicians to support the district's 10,000 plus computers and 200 servers, Mr. Randolph needed an archiving solution that was affordable, reliable and required minimal IT involvement.

### Solution

In addition to the ArcMail appliance, Mr. Randolph evaluated archiving solutions from two well-known vendors that ranged from \$300,000 to \$500,000. "They required us to purchase hardware and software and were complex to set up," he said.

"I generally believe that you get what you pay for", Mr. Randolph added, "but this seems to be the exception to that rule, as the ArcMail solution was significantly more affordable and gave us all the functionality we need."

Having the ability to test the ArcMail unit on a trial basis before purchasing it, facilitated the selection process.

Mr. Randolph said "There was no complexity, I configured it myself in a few hours. I wasn't necessarily looking for an appliance, but I was pleasantly surprised. I don't have to dedicate a server to it or put any software on it. And once it's up and running, you don't have to think about it."

### Value

An immediate return on investment for St. Louis Public Schools is that ArcMail's simple search and restore functions have reduced the process of recovering staff email from hours to seconds. A copy of every email and attachment is automatically indexed and archived on the appliance. Administrators and authorized users can use the web-based interface to instantly find messages using standard email fields or keywords. (See sidebar.)

Mr. Randolph appreciates that the ArcMail unit requires no regular intervention from his staff. "It emails me a report every day so I can see our volume at a glance. Otherwise, I might forget it was there." He estimates that the ArcMail U3120 will easily accommodate the district's email archiving requirements for the next five years.

In addition to the substantial savings over the other systems Mr. Randolph considered, he feels that ArcMail's support is far more personal and responsive. "Whenever I've had a question, they called back right away, and I like that I talk to the same people. It's good to know that if I ever have a real problem, I'll get support from someone who knows my system as well as I do."

Thomas Randolph, IT Director for the St. Louis Public School District, described the dramatic difference in the email recovery process before and after implementing ArcMail:



### Before ArcMail:

"I'd have to go into the Exchange message tracking center. Then enter who the email was To or From and run the search. That takes hours and drains Exchange resources, so I'd run it at night. Exchange shows you a log of matches, which you then have to parse through. And you only get the Subject of the email, not the body. To get the actual message you have to go retrieve it from back-up, which also takes hours."

### With ArcMail:

"I open the web interface and search by To, From, Subject, Date or any keyword I can think of. The email with any attachments comes up in seconds. I can send it to a mailbox or put on a disk."
